5 Year Written Limited Warranty

Cabinetry Refinishing Enterprises warrants the original consumer/purchaser for 5 Years or as long as they own their home that their products or refinishing will be free from defects in material and workmanship under normal use. This warranty is only applicable to products or services used in residential applications and is not transferable to subsequent owners. Should defects in material or workmanship exist during the applicable warranty period in our product or finish, Cabinetry Refinishing Enterprises will elect at our discretion to either repair or replace the defective material or component, free of charge. This warranty covers only cabinet modifications and finishes of the products (new doors, drawer fronts, drawer box's, hinges, etc.) supplied by Cabinetry Refinishing Enterprises. Not covered under this warranty are counter tops, appliances, plumbing fixtures, etc. or the costs, including labor, to remove, repair and/or reinstall materials and related components such as fittings, appliances, etc.

This warranty shall become void if the cabinets are in any way modified. Furthermore, this warranty does not cover Cabinetry Refinishing Enterprises products or service's damaged by misuse, neglect, abuse, acts of God, exposure to water, extreme temperatures or the effects of normal wear and tear.

Natural woods may vary in color, characteristics and exhibit subtle changes as they age. For example, white painted face frames may eventually have visible cracking around the joint area and cabinet colors may darken or lighten over time. Sunlight, smoke, household cleaners and other environmental conditions may also affect the color match over time. These variations are considered to be the nature of the material and/or finish in relation to their environmental exposure and are not covered under this warranty.

Cabinetry Refinishing Enterprises reserves the right to alter design, specifications and/or material without obligation to make similar changes to products or finish's previously manufactured.

The repair(s) or replacement(s) are contingent upon the current product offerings of styles and options within Cabinetry Refinishing Enterprises product line at the time of the warranty claim. If a warranty claim is filed after a product becomes obsolete, Cabinetry Refinishing Enterprises reserves the right to honor the warranty in one of the following fashions: 1. To replace, repair and/or refinish the affected component. 2. To replace the affected component and any other component(s) in the residential application to achieve a uniform appearance with a similar and comparable product style or finish of the originally purchased style or finish.

If components are replaced or refinished, Cabinetry Refinishing Enterprises cannot guarantee that the finish of these replacements will exactly match the finish and appearance of the components in the residential application. This is due to the changes that occur during the woods' natural aging process, affecting its color and grain.
