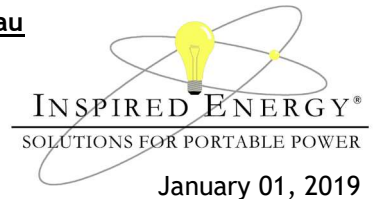

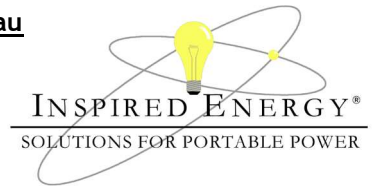

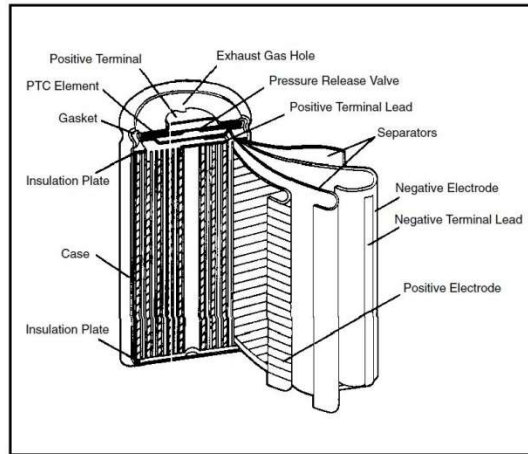

 The specific chemical formulae are proprietary to the cell manufacturers.




The cross-section construction for the Li Ion cells used in these products is as shown below:
