TRANSFERABLE 2-YEAR LIMITED WARRANTY (U.S.A. and Canada)

Amp RX LLC (Colby) warrants that the Colby or Park product you have purchased shall be free of any defects in parts and workmanship if used under normal operating conditions for a period of two (2) years from the date of purchase, except that footswitches and speakers are warranted for a period of one (1) year from date of purchase and light bulbs, vacuum tubes, cables and all other included accessory products are warranted for a period of ninety (90) days from date of purchase. This warranty shall run to the original purchaser when purchased from an Authorized Colby, Park Dealer or direct from Colby Amplification and any transferee of a retail purchaser. IMPORTANT: PLEASE RETAIN YOUR SALES RECEIPT, AS IT IS YOUR PROOF OF PURCHASE COVERING YOUR LIMITED WARRANTY. TO TRANSFER THE WARRANTY TO A SUBSEQUENT PURCHASER, YOU MUST ENDORSE THE SALE OF THE PRODUCT TO THE SUBSEQUENT PURCHASER ON THE FRONT OF THE SALES RECEIPT. THIS LIMITED WARRANTY IS VOID WITHOUT SUCH ENDORSED SALES RECEIPT.

Defective products that qualify for coverage under this warranty will be repaired without charge. If repair is not possible the product will be replaced at Amp RX LLC's discretion. The Authorized Dealer from whom you purchased your product may also be authorized for warranty service and should be the first point of contact when service is required. TRANSPORTATION COSTS ARE NOT INCLUDED IN THIS LIMITED WARRANTY.

Any repair or service performed by any person or entity other than an Authorized Colby Electronics Service Center is not covered by this limited warranty.
