Pursuant to the resolution of the Syndicate passed at its meetings held on 15-11-2016, the following modifications to the existing General norms/guidelines for affiliation of colleges/institution to Bangalore university are hereby notified. These guidelines are effective from the academic year 2017-18:

GUIDELINES FOR PERMITTING POSTGRADUATE PROGRAMMES IN AFFILIATED COLLEGES</p> <p>The following shall be the guidelines for permitting Postgraduate Programmes in an affiliated Colleges:</p> <p>I. General</p> <p>2. Colleges having permanent affiliation or atleast five years of continuous affiliation only shall be eligible to start postgraduate programmes. Those colleges which do not have accreditation shall apply to NAAC for accreditation within 2 years from the date of affiliation to P.G. programmes.</p>	<p>2. <u>Existing Colleges or Trust/Societies having infrastructure facilities as stipulated in these guidelines are eligible to apply for fresh affiliation to start P.G. programmes.</u></p>

All the affiliated colleges are requested to make note of the above said changes in the guidelines. The affiliated colleges and Managements seeking fresh affiliation to P.G. courses may obtain the additional course affiliation application (P.G.) /fresh affiliation application form (new colleges) from the Office of the Co-ordinator, Prasaraanga Sales Unit, Palace Road, Bengaluru, on payment of application fee of Rs.1,000/- through D.D. drawn in favour of the 'Finance Officer, Bangalore University, Bengaluru-560 056'. They have to submit the filled in affiliation application in eight sets with originals with a late fee of Rs.5,000/- along with the prescribed affiliation fee in the form of DD drawn in favour of 'Finance Officer, Bangalore University, Bengaluru' (to be remitted by the college to the University funds on the day of submission of application at the DD collection centre of the Finance Branch of the University) within 15-12-2016.
