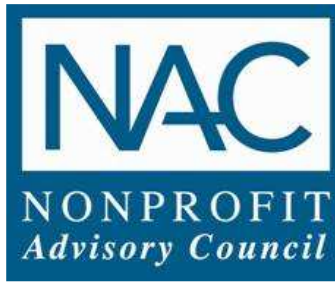

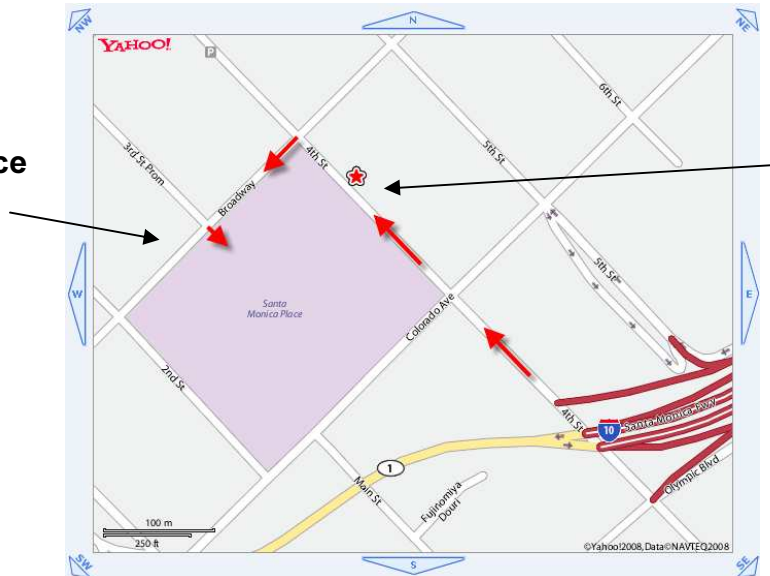

Turn left at Broadway (2nd signal) and enter Santa Monica Place parking garage on your left. The Ken Edwards Center is located on the east side of 4<sup>th</sup> Street in the middle of the block between Colorado and Broadway, directly across the street (looking east) from Santa Monica Place.
