Dr. Oliver is a native of Valdosta and holds a B.B.A. from the University of Georgia, an M.Div. from Emory University, and a D.Min. from the San Francisco Theological Seminary.

He retired from the South Georgia Conference, The United Methodist Church, in 2016 after 52 years of ministry. His appointments included: Assoc.
