



National Executive Committee (NEC)- The National Executive Committee (NEC) is responsible for the policies, procedures, and convention site selections for conducting future National Square Dance Conventions®.

National Square Dance Convention® - is a Registered Trademark of the National Executive Committee. (® must always be used unless abbreviated as NSDC)

National Square Dance Convention® Guidelines - This document contains many years of experience, policies, and procedures to be used by the Convention Committee to develop the Convention Plan.

NEC Members - Members of the NEC are past General Chairman to a prior NSDC.

NEC Area Advisor - Each NEC Member is assigned to a geographical area in the United States as the Area Advisors.

NEC Phase Advisor - Each Member of the NEC is appointed as a Phase Advisor to a phase activity, i.e. Fashion Show, Round Dance Program, Sew & Save, etc.

NEC Advisor - When a Bidding City has been identified as a proposed upcoming convention location, the NEC Area Advisor becomes the NEC Advisors to this organization along with another NEC Member (couple/solo) they select to advise this NSDC.
