With the great boating we are enjoying this month, it's hard to believe that we need to start thinking about winter storage. Planning ahead, however, is essential to good service.

STORAGE - Attached you will find our 2020 Winter Storage Contract along with a copy of our rates. We will be hauling 7 days a week with mechanics on hand for your convenience. Water and electricity will be available for your convenience. Cradle pick-ups begin in September. We are prepared to transport your cradle from another location to PBB at NO CHARGE. Please let us know as soon as possible if you will be requiring this service. PBB & DBB want to do all they can to ensure that your haul-out, winterization, and storage are a pleasant experience. Please keep in mind that winter storage revenue is essential in providing for the success of PBB & DBB as it enables us to continue to provide all the year-round services you deserve. Any boats on trailers for outside storage will be stored at DBB's facility.

CRADLES & TRAILERS - Please make sure that trailers and cradles are in working order. We have tags available for identification for you to clearly mark your trailer/cradle with your name. The cradle pick up form can be completed in the store.

SAVE \$ - PBB & DBB are offering a 10% discount on the winter storage rate only if the fee is paid by haul-out.

PLEASE - Remove your dock boxes and other equipment stored on the docks. Please empty your boat of valuable items such as stereos, radios, outboard motors, fenders, etc. PBB & DBB will not be responsible for these personal items.

PLEASE - Remember to fuel up prior to haul-out as this service will not be offered at the time of haul-out. It is advised that you not fill your tank beyond 3/4 to 7/8 to avoid spillage due to expansion.

SAILS - Should be placed in sail bags and stored in the boat's cabin out of the mechanic's way for engine and head winterizing.

EVERY BOAT - Will have a pumpout done at haul-out time unless noted "NO" by owner.


DINGHIES - In the past we have had dinghies left on shore or behind the boat. It is the responsibility of the owner to deflate their dinghy and store on their boat or PBB will enforce the charge of \$100.00 to deflate and transport to the shop. **Advance notice is required from the Owner for removal of dinghies and/or outboards from inside storage.**

KEYS - **Please make certain that PBB & DBB have the necessary keys to access your boat.**

Winter Storage Agreement

This agreement made this _____ day of _____ 2020 by and between PLATTSBURGH BOAT BASIN, Inc. (hereinafter 'PBB') a duly organized corporation existing and duly authorized to conduct business in the State of New York with offices located at 5 Dock St., Plattsburgh, New York, 12901 and _____, residing _____ (hereinafter 'Boat Owner').

PBB agrees to furnish space and or services as indicated on page three for the charge shown. The BOAT OWNER will pay for same as stated. Winter storage fees are due when the boat is hauled out of the water. A service charge of 1.5% will be imposed on any amounts not paid 30 days from invoice date. This is an effective rate of 18% per annum.

PBB shall have a lien upon the BOAT OWNERS'S boat and equipment for space or service charges. To satisfy the lien, PBB may sell the boat and/or equipment at public or private sale if the debt is not fully satisfied 3 months after due date. The BOAT OWNER shall be obligated to pay any deficiency resulting from said sale to include attorney's fees and all other cost of collection.

The BOAT OWNER is required to leave keys to their boat at PBB's marina office prior to docking or mooring to said boat. Sufficient lines, fenders, mooring snubbers and other necessary tie-up gear required, will be furnished aboard the boat by the BOAT OWNER prior to launching and the BOAT OWNER accepts full responsibility for the condition of such gear and for any damage that may result from its failure. **The BOAT OWNER will be responsible for his/her own mooring and/or dock lines, including picking them up at haul out. PBB does not take responsibility for holding the BOAT OWNER'S lines until the following season.** PBB reserves the right to relocate the BOAT OWNER'S boat to a different space when deemed necessary.

The BOAT OWNER agrees to have his/her boat out of the rented space by the end of the season (October 15th) as PBB will start pulling docks by October 15th. If BOAT OWNER'S boat is still at the space on October 31st, PBB can remove, winterize and store the BOAT OWNER'S boat at the BOAT OWNER'S expense. PBB will observe the haul and launch dates as established herein as nearly as possible in keeping with its boat handling capacity and as weather conditions permit.

The BOAT OWNER agrees that PBB shall not be liable under any circumstances whatsoever for any damage of any property of the BOAT OWNER'S boat including the boat described herein, whether damage is caused by confiscation, order of any government or public authority, discoloration from natural or inherent causes, collision with underwater objects, high or low water, fire, theft, weather conditions, vandalism, and/or acts of God. PBB is not responsible for any losses on or damage to other boats or property caused by the BOAT OWNER. Any boat that poses a safety risk or environmental hazard shall be removed immediately by the BOAT OWNER at his/her expense or removed by PBB at the expense of the BOAT OWNER.

INSURANCE – THE BOAT OWNER SHALL BE RESPONSIBLE FOR OBTAINING AT BOAT OWNER'S EXPENSE ANY PROPERTY DAMAGE, FIRE, THEFT, HULL AND PROTECTION & INDEMNITY OR SIMILAR INSURANCE UPON SAID BOAT. PLATTSBURGH BOAT BASIN, Inc. SHALL NOT BE REQUIRED TO PROVIDE ANY SUCH INSURANCE.

It is understood and agreed by the BOAT OWNER that he/she may not hire or otherwise employ outside help to do work on the vessel while it remains at PBB other than marina employees. If BOAT OWNER does his/her own work, he/she must dispose of the waste materials such as oil and gas. If BOAT OWNER elects PBB to do the disposing, the BOAT OWNER will be charged a reasonable fee. Any person leaving old oil or gas around the marina or any person bringing gas in containers to fuel up their boat will be deemed in default of this agreement, asked to leave the marina and forfeit any monies paid to PBB! The BOAT OWNER shall be responsible for the conduct and actions of his/her guests as well as him/herself!

Any vehicle not properly parked will be towed away at the owner's expense. Each BOAT OWNER will be issued two passes as part of their PBB reservation. One pass will be for the BOAT OWNER'S vehicle; 2nd will be for one guest vehicle. These passes must be displayed on the car while parked at PBB or PBB will assume that the car belongs to someone other than a BOAT OWNER and the car will be towed away at the owner's expense.

The BOAT OWNER understands and agrees that PBB makes no specific or implied warranty as to the safety, condition, or suitability of any equipment, property or device owned or leased by PBB which may be used by the BOAT OWNER, family members or guests.

The BOAT OWNER covenants and agrees to save harmless and indemnify PBB from any claims, suits and damages sustained by PBB arising from the operation of this agreement including responsible attorney's fees incurred by PBB in defense of any claim brought by any person(s) including the BOAT OWNER'S family, guest or invitees.

GOVERNING LAW: This agreement and the performance thereof and any and all claims, rights, duties, or obligations of the parties hereto shall be governed, interpreted, construed, regulated, controlled, and determined by the application of the laws of the State of New York.

SITUS: Any claim or dispute arising hereunder must be brought in the State of New York, Supreme Court, County of Clinton.
