December 9, 2019 Meeting Resolutions

19-36 RESOLUTION APPROVING PUBLIC SAFETY EMERGENCY RADIO COMMUNICATIONS SYSTEM INTEROPERABILITY AGREEMENT WITH ORANGE COUNTY.

Whereas, Orange County, through its Department of Emergency Services, is upgrading its county-wide public safety communications system; and

Whereas, Orange County has invited the Village of Chester to participate in its upgraded system and has tendered to the Village a form of Agreement for such purpose; and

Whereas, pursuant to the terms of such Agreement, Orange County will be purchasing and transferring to the Village the equipment necessary for participation in the system by public safety personnel of the Village; and

Whereas, the Mayor and Trustees of the Village have determined that it will benefit the residents of the Village for the Village to participate in this system; and

Whereas, the Attorney for the Village of Chester has approved the form of such Agreement,

NOW, THEREFORE,

IT IS HEREBY RESOLVED, by the Village of Chester Board of Trustees that the Mayor is authorized to enter into the agreement with Orange County, in the form submitted to this meeting, and it is further

RESOLVED, that the Clerk is directed to forward such Agreement, when signed by the Mayor, to the appropriate officials of Orange County; to file the agreement when it is fully executed, and to notify the Village's insurers of the existence of such Agreement and provide a copy of the Agreement to the Village's insurers.
