This contract between North Carolina Driving School, hereinafter called the School, and _____, hereinafter called the Student, covers a course in Driver Education, which includes _____ hours of behind-the-wheel instruction. The School and the Student agree to the following terms and conditions:

1. All fees are payable in advance through the enclosed payment schedule. Payment accepted by credit card, debit card; personal check or money order. The School will not refund any tuition monies or any part thereof when actual services have been rendered.
2. All educational materials issued are the property of the School and they must be returned in good condition at the completion of the course.
3. **If you cannot keep your scheduled appointment for driving, you must notify the instructor at least (24) hours in advance.**
4. No certificate of completion will be issued until all fees have been paid in full.
5. There will be a \$25.00 service charge on all returned checks.
6. The School will complete the course within a reasonable length of time; however, it cannot be held responsible for delays caused by unsafe driving conditions due to bad weather, mechanical problems, or any other reasons over which it has no control. The School will give as much notice as possible, if any delay becomes necessary.
7. The fees contained herein cannot be guaranteed longer than (90) days from the beginning date of the course.
8. The School cannot guarantee that the Student will successfully pass the examinations given by the Division of Motor Vehicles upon completion of the course. The School will undertake to exert its best efforts in teaching the Student to meet the requirements of the examinations.
9. If the student is less than eighteen (18) years of age, a parent or guardian must sign this contract.
10. Student may use the company vehicle for the actual license exam if the student has completed a minimum of 8 hours behind the wheel training. Use of the school vehicle by the student for the Division of Motor Vehicles road test after eight hours of instruction is at the discretion of the instructor.
11. Under this agreement an instructor may not provide behind-the-wheel training to more than three individual students
