PROCEDURE:

Step 1: Register here (Entry Fee: \$5 per entry):

Step 2: Create a video of your act and submit by email

to <u>talentshow@millstoneriverpta.org</u> latest by 10th of December, 2020.

Step 3: Celebrate the creativity of the Millstone Students during the 3rd week of December 2020, with the **Release of a beautiful video compilation** and a **Certificate of Participation**.

GUIDELINES:

- 1. Email an unedited video to <u>talentshow@millstoneriverpta.org</u> as an attachment. (NOT a link)
- 2. If your act is a cover/copy of an act, please include the name of the artist, title of the piece in your email.
- 3. Raw footage is best, no edited videos, no titles, or no intros we will be editing them into the final show.
- 4. Title your video file with the Student's First Name, Last Name and include it as your subject in the email.
- 5. Make sure your lighting and audio is bright and clear voice should be louder than music.
- 6. The time duration for an Act should be no longer than 2 minutes.
- 7. All Submissions must be clean, age appropriate and non-censored and hold a positive message. This rule is a must for ALL acts: singing, dancing, or background music, etc.
- 8. Parents must review / screen their student(s) act for appropriateness, quality, and length.
- 9. No explicit language or content allowed.
- 10. We may ask a student to resubmit their act if it needs a little fine-tuning.
- 11. We reserve the right to not to include the act in the virtual Talent Show if the guidelines are not adhered to.
- 12. By submitting a video, you agree to it being shared and posted on the MRSPTA Social Media (Weekly Newsletter, Facebook, Twitter, WhatsApp Groups). (There shall a mandatory section to give Media Release Permission on the Registration Form).
