

IN 2017, 4,417 INDIVIDUALS IN 1,524 FAMILIES WERE SERVED IN THE FOOD PANTRY. ANYONE WHO COMES TO THE CLOTHES CLOSET CAN SPEND 20 MINUTES SELECTING GENTLY USED CLOTHES. WE SERVED 1,266 FAMILIES IN THE CLOTHES CLOSET WHO ACCOUNTED FOR 3,691 PEOPLE.
