# Artistry Dance Project Release

## Payment Information:

Tuition is due on the first day of each month. If tuition is paid after the tenth of the month, a \$20.00 late fee will be applied to the outstanding account balance. A \$30.00 returned check fee will be charged for any checks returned by the check writer's bank. Summer tuition is due upon registration.

## Credit Card Charges:

Monthly tuition charged on credit cards will be charged on the first day of each month. If you do not want tuition to be charged to your credit card, you may pay by cash or Check made payable to Artistry Dance Project prior to the first day of the month. You understand and agree that should you not pay tuition prior to the first day of a month, your credit card will be charged the full tuition amount for that month.

## Photography/Videography Release:

By signing the registration form, a dancer engaging in activities through Artistry Dance Project, LLC gives it permission to use any photographic and/or video images of such dancer for archival, documentation, or publicity purposes including but not limited to, Artistry Dance Project, LLC affiliated websites, Facebook pages, and advertisements.

## Class Cancellations

Some classes held at Artistry Dance Project, LLC require a certain number of students. In the even a particular class sponsored by Artistry Dance Project, LLC cannot be held do to the minimum number not being attained, a credit will be applied toward a like class, or if no like class is available, a refund of the full class tuition will be paid.

## Release and Waiver:

I do hereby release, waive and discharge Artistry Dance Project, LLC ("Studio") and its affiliates, trustees, directors, officers, employees and agents ("Releasees") from any and all present and future liabilities, obligations, damages, losses, claims, demands, costs or expenses ("Claims") that may be made by me, my family, estate, heirs, or assigns for property damage, personal injury, loss, obligation, expense or penalty, including attorneys' fees, for personal injury, or wrongful death arising as a result of my participation in Studio classes, events or instructional workshops ("Studio Activities"), whether caused by the negligence or carelessness of Releasees or otherwise including, without limitation, in connection with transportation to and from the Studio. I understand that participation in Studio Activities involves certain risks, including, but not limited to, serious injury and death. I am voluntarily participating in the Studio Activities with knowledge of the danger involved and agree to accept all risks of participation.

I understand that Releasees do not have medical personnel available at the Studio but I consent to administration of first aid and other medical treatment in the event of injury or illness. I also agree to indemnify and hold harmless the Releasees for all Claims arising out my participation in Studio Activities and all related activities and any medical treatment.

By signing below, I or my son or daughter knowingly and voluntarily assume(s) all such risks, and assume(s) sole responsibility for any accident or injury to me or him/herself and other persons or property arising out of or in connection with participation in Studio Activities.
