Basic Rules (For complete rules, pick up copy at event site or visit www.mjbt.org)

1. Check In begins at 8:00am, Paddock at 8:45am, Bowling at 9:00am
2. Event is open to **all youth and adult USBC sanctioned** players that have not reached their 20th birthday by August 1, 2020.
3. All competition is scratch. Handicap will not be given to any player.
4. Separate women's division if 6 or more female entries.
5. All players bowl a 9 game qualifier, moving lanes after each game. Top men and women go to match play or stepladder finals. Total pin fall (actual + bonus) after match play or stepladder winner determines champion. No carry-over of pin fall.
6. Scholarships awarded to all players making finals play. Scholarships paid out for high qualifier and high game out. Plaques also awarded to champions. All award fees returned 100%.
7. No denim, caps or hats allowed. All bowlers must wear appropriate shirt with name on back and MJBT logo securely attached. Dress skirts of appropriate length are acceptable for women. Dress slacks acceptable for male bowlers. New players will be allowed 2 events to obtain appropriate shirt/logo.
8. Entry fees are as follows:
Pre-Paid Normal Entry: \$28 prize fund, \$11 lineage, \$4 year-end, \$2 expenses, \$5 director = \$50 total
Pre-Paid First Time (only) Entry: \$23 prize fund, \$10 lineage, \$1 year end, \$1 director = \$35 total
Late / Walk In Entry: add \$10 to above fees.
9. Payment for membership fees, bracket entries and Junior Gold can be added to entry check. See reverse for costs.
10. Membership fees are due on by the second event in the season for all players. Membership fees on a seasonal basis and not a calendar year.
11. USBC rules apply where no other MJBT rule applies. Complete rules available at event site or at www.mjbt.org.
12. Entries not received on/by deadline date, or received on event day subject to \$10 late charge. Walk in entries accepted on space available basis only. Entries should be sent at least seven (7) days prior to the deadline to help ensure timely delivery.
13. Failure to show for scheduled event without approved cancellation will result in loss of all entry fees.
14. Confirmations will only be posted online, and not sent out to individuals. To confirm, visit our website at www.mjbt.org. In the event entries exceed posted limits, a waiting list will be used.

16. Lane conditions will be held confidential and will be posted at check in. Lane conditions will change from event to event. Do not contact center or its employees to obtain information on bowling patterns to be used.
