Purpose

Wise Adult Day Health is a program for adults experiencing health care related issues or whose ability to function independently is limited. Wise is designed to provide quality services, including daily leisure, recreational and preventive health activities to aging and/or disabled adults during daytime hours when caregivers can't be with them or are in need of respite.

Goals

- To provide a safe, supportive environment that allows participants to maximize their quality of life
- To provide preventive health care services to participants
- To provide individualized, self-directed social and leisure experiences for participants

Services

- Activities which support new experiences, build self-esteem and ensure access to health and social services
- R.N. oversight of all health related activities, including restorative and maintenance therapies, nutritional consulting, participant/caregiver training in preventive health, medication management, and vital signs monitoring
- Nutritionally balanced continental breakfast, hot lunch and afternoon snack served daily
- Transportation to and from Wise Center
- Community access with monthly outings
- Service Coordination provided by an on-site Social Worker including outreach and support
- Individual counseling available weekly by a professional licensed therapist
- Personal care provided by specially trained staff
