

**KATY UNITED VOLLEYBALL  
2019 – 2020 FEES & PAYMENT  
TERMS AND CONDITIONS AGREEMENT**

**ALL MONIES PAID TO KATY UNITED ARE NON-REFUNDABLE.** Upon signing this Fees and Payment Agreement, (the “Agreement”) the undersigned Parent acknowledges and agrees that the entire amount of the Total Club Season Fee (defined below) shall be due and payable (except as exclusively provided below) by the undersigned, either by lump sum or installments, to Katy United, no matter the player’s status with the team during the season. The “Agreement” shall mean the sum of the “Team Commitment Fee” and the “Remaining Balance” of Club Season Fee after “Team Commitment Fee is paid (detailed below) and on our Club Season Fee Form on our website.

A \$600 non-refundable “Team Commitment Fee” check is due and payable at tryouts and made payable to Katy United. Katy United will deposit the “Team Commitment Fee” if an offer is made and accepted. Otherwise Katy United will destroy the check.

Unless otherwise agreed in writing by the Katy United Club Director, Club Season Fees can either be (i) paid in full (due and payable by or before August 1st) via cash or check or (ii) paid through 9 equal monthly installments (due and payable on the Fifth day of each month beginning August 2019 and ending April 2020) via credit card or bank debit card (3% convenience fee will be included). Installment payments are considered delinquent after the 8th of each month and will be subject to a \$20 late fee. All accounts must be paid in full by April 30th. The undersigned Parent is responsible for the timely payment of the Fee Agreement and all other fees. Club Season Fees will not be prorated for partial month’s participation.

Players with a delinquent balance will not be permitted to participate in practice sessions, competitions, or tournaments unless arrangements are in place to bring the account up to date and current. **THERE ARE NO EXCEPTIONS TO THIS POLICY. PLAYERS WITH DELINQUENT ACCOUNTS WILL NOT BE ALLOWED TO ATTEND ANY PRACTICES OR TOURNAMENTS WITH THE TEAM UNLESS ARRANGEMENTS ARE MADE TO SATISFY PREVIOUS PAYMENT REQUIREMENTS.**

The applicable Club Season Fee will be determined based on whether the player participates on a National Team, Regional Team, or Local Team. AAU/USAV National Championship Tournament fees and College Coach Camp fees are included in National Team Fees ONLY.

In the event a player has a sibling join the club, a sibling discount of 5% may be applied to the Remaining Balance of Club Season Fees. The sibling discount will be applied to the sibling with the lesser Club Season Fee and will not be combined with any other discount.

TERMS AND CONDITIONS AGREEMENT**

**Terms and Conditions:**

All monies paid to Katy United (the “Club”) are non-refundable. All Club Season Fees (as defined in the Fees and Payment Commitment) are due and payable either by lump sum or installments to the Club no matter the player’s status with the team during the season. All program registration fees are non-refundable. All program fees must be paid in full before first date of program. All Club and Starlights registration fees and Fee Commitment fees are non-refundable. Once a parent and player have committed to play for the Club or Starlights season, the parent and player are also committing to the total season fees in their entirety. This also includes National Championship tournament fees which are built into National team club fees.

In the event the player and parent decide to leave the Club for any reason during the season and the parent has paid all fees to the Club in a lump sum, the Club shall have the right, in addition to any other remedy allowable by law, to retain all sums paid to the Club as liquidated damages. In the event a parent and player leave the Club and are paying the fees in installments, the Club shall have the right, in addition to any other remedy allowable by law, to retain all sums paid to the Club as liquidated damages, and parent agrees to pay the Club the remaining amounts due under the installment plan on demand. Parent and Club agree that such damages are not a penalty but represent the parties' best estimate of the actual damages which the Club will sustain upon a parent and player leaving the Club, which damages are substantial but are not capable of precise determination. No delay or forbearance by the Club in exercising any right or remedy hereunder shall be deemed to be a waiver thereof.
