**RESOLUTION NO. 244**

**COUNTRYSIDE BOULEVARD AND ALGONKIAN PARKWAY SHOULDER,  
MEDIAN AND STORM WATER NETWORK REPAIR**

**WHEREAS**, Article III, Section 3 (b) (1) of the Declaration of Covenants and Restrictions of the CountrySide Proprietary grants the Board of Directors all powers for conducting the affairs of the Proprietary; and

**WHEREAS**, the Board of Directors of the CountrySide Proprietary wish to exercise their powers and duties in good faith with a view to the interests of the Proprietary; and

**WHEREAS**, the graveled road shoulders of Countryside Boulevard and Algonkian Parkway have been allowed by VDOT to widen beyond the customary four feet width; and

**WHEREAS**, the shoulders now encroach on portions of common ground; and

**WHEREAS**, storm water run off has caused significant erosion to the medians, shoulders and storm water ditches on CountrySide Boulevard and Algonkian Parkway, and

**WHEREAS**, the median and shoulders of Algonkian Parkway at various CountrySide locations have been severely eroded by storm water run off; and

**WHEREAS**, on Countryside Boulevard near the entrance to CountrySide Elementary school a storm water drain is filled with mud and rendered non-functioning causing storm water to spill over the roadway; and

**WHEREAS**, in the road shoulders on the east and west side of Countryside Boulevard adjacent to the CountrySide Elementary school deep gullies have been carved by storm water run off; and

**NOW, THEREFORE**, be it **RESOLVED** that the CountrySide Proprietary Board of Directors is requesting that VDOT/Loudoun County restore the shoulders, median and storm water network areas of Countryside Boulevard and Algonkian Parkway to its original condition and purpose.
