

NAIGC Privacy Policy

Version 1.2 / Last Amended & Approved: 4/24/2019

I. Purpose

- A. This Statement of Privacy (“Statement”) applies to the National Association of Intercollegiate Gymnastics Clubs (“NAIGC”), and its website, (“NAIGC Website”) and governs all data collection and usage by the NAIGC. Protecting the private information of our members is the NAIGC’s priority, and by using the NAIGC Website, you consent to the data practices described in this Statement.

II. Collection of your Personal Information

- A. When you use the NAIGC Website (currently located at www.naigc.net, but also redirecting from www.naigc.org), you may be asked to provide personally identifiable information, such as, but not limited to, your name, address, email address, or phone number, and other demographic information, such as, but not limited to, date of birth, gender, and student status. The NAIGC collects and stores the information you provide. If you purchase a product or service from the NAIGC Website, the NAIGC and/or its authorized agents collect your billing, shipping, and credit card information in order to complete the purchase transaction, but does not store this information. When you use the NAIGC Website, or the pages of certain NAIGC Partners, the NAIGC may automatically collect information about your computer hardware and software; this information may include: your IP address, browser type, domain name(s), access time(s), referring website address(es), and/or other information. This information is used to maintain the high quality of the NAIGC Website. The NAIGC is not responsible for the privacy statements or other content on websites outside of the NAIGC Website. The NAIGC encourages you to review the privacy statements of non-NAIGC websites that may be linked to on the NAIGC Website so that you can understand how those websites collect, use, and share your information. The NAIGC may combine information about you that we have with information we obtain from business partners or other companies.

III. Use of your Personal Information

- A. The NAIGC uses the information described above to operate the NAIGC Website and optimally deliver the NAIGC’s products and services. The NAIGC may contact you via surveys through contact information you have provided to conduct research about your opinion of current services or of potential new services that may be offered by the NAIGC or through the NAIGC Website. The NAIGC does not sell, rent, or lease its customer lists to third parties. When necessary, the NAIGC may share your personal information or computer hardware or software information with trusted partners to help perform statistical analysis, contact you with information relating to the NAIGC, provide customer support relating to the NAIGC or its products or services, or arrange for deliveries of NAIGC products or services. All such third parties are prohibited from using your personal information except to provide these services for the NAIGC, and they are required to maintain the confidentiality of your information. The NAIGC will disclose your personal information without notice only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on the NAIGC or the NAIGC Website or to establish or exercise our legal rights or defend against legal claims; (b) protect and defend the rights or property of the NAIGC; or (c) act under exigent circumstances to protect the personal safety of users of the NAIGC Website, members of the NAIGC, or the public.
- B. Your personal information may be transferred to countries other than your own to process and store data in accordance with our Privacy Policy and to provide you with products

and services. Some of these countries may not have the same data protection safeguards as the country where you reside. By using our products and services, you consent to us transferring your data to these countries.

IV. Security of your Personal Information

- A. The NAIGC works to protect the security of your payment information by using Secure Sockets Layer (SSL) software, which uses encryption and other security measures to protect your information during transmission. Your payment information is used for billing only. Your payment information will never be stored on NAIGC's server and is provided only to our credit card merchant, Paypal.

V. Changes to this Statement

- A. This Statement of Privacy may be updated at any time to reflect company and customer feedback by a vote of the NAIGC Board. The NAIGC Board will post any significant changes to This Statement of Privacy to the NAIGC Website. The NAIGC encourages you to periodically review this Statement to be informed of how the NAIGC is protecting your information.
