## **Terms and Conditions for Participating in the Dragon on the Lake Dragon Boat Races**

**1. Rules:** The Race Rules follow the "Official International Dragon Boat Regulations."

- There's a required minimum of 8 (eight) women paddling in each Dragon Boat in each heat.
- The minimum age for paddlers is 14 years old.
- Each team will include 20 paddlers, 1 drummer and 1 steer person (provided).
- Dragon Boats, life jackets and paddles are provided by Great White North.
- Race goes on regardless of rain, postponed during lightning and thunderstorms.
- Team captains must attend a mandatory meeting Sunday at 8:45am in Green's Park.
- Team waivers will be signed on Saturday at registration.
- Teams can set up a 10x10 tent in Green's Park and bring food and beverages. Don't forget the sunscreen!
- No alcohol is allowed in Green's Park.

**2. Photo Release-** In registering, You also give permission and consent for photographs to be taken of yourself during the event. You understand that these photos may be published and used by 360 Event Productions, The Orion Art Center, Dragon on the Lake and its affiliates to illustrate and promote the educational experiences, the Orion Art Center and marketing programs.

**3.Cancellation.** No refunds will be issued after full payment and application are received and processed. No refunds will be given due to cancellation of the event by local authorities or due to weather or force majeure. Participants WILL be refunded if the event is cancelled due to Covid.

**4.Conduct of Character-** Participant agrees to conduct themselves in a respectful, cooperative manner to event staff, volunteers, other participants, and guests of the event. Any behavior deemed inappropriate or disruptive by Event Management may result in expulsion from the Event and no refunds shall be tendered. Participants that are expelled may not be allowed to participate in future events. Any participant deemed to be causing a scene, lecturing, making political statements or using this event as an avenue for a radical display will be expelled.

**5. Hold Harmless-** It is expressly understood and agreed by participant that neither Dragon on the Lake, 360 Event Productions, Orion Art Center, its affiliates, officers, officials, sponsors, employees, partners, agents, or contractors shall be liable for loss or damages to the goods or properties of Participant. On signing the Dragon on the Lake Dragon Boat AGREEMENT, Participant releases and agrees to indemnify and Defend Dragon on the Lake, 360 Event Productions, Orion Art Center, its officials, sponsors, employees, partners, agents, or contractors, and hold them harmless from any suit or claim from property damage or personal injury (including punitive damages) by whomsoever sustained, including Participant and Participant's display space or arising out of participation in, Dragon on the Lake Dragon Boat expressly including such damage or injury resulting in any part of negligence of one or more of the aforementioned indemnities. The performance of this agreement by either party is subject to the acts of God, war, government regulation, disaster, civil disorder, the public enemy, curtailment or transportation facilities, or other emergency over which neither party has control making it illegal or impossible to provide the facilities to hold function or for disruption of the function. Dragon on the Lake, 360 Event Productions, Orion Art Center, its officials, sponsors, employees, partners, agents, or contractors shall not be liable for any damages that arise due to such conditions.

**6.Cancellation/Disruption of Dragon on the Lake-** Should any eventuality cause cancellation or disruption of the event, Dragon on the Lake, 360 Event Productions, Orion Art Center, its officials, sponsors, employees, partners, agents, or contractors shall not be liable for any expenses incurred by Participant. In no case shall the amount of refund to participant exceed the amount of the participation fee paid.
