**CANDIDATES' FORUM ISSUE**

Citizens for Lexington Conservation, Inc. devotes this annual issue of its newsletter to candidates' statements in order to help you, the voter, cast your ballot effectively. All candidates for office were sent a letter soliciting their response to the following question (not all responded):

The Community Preservation Committee is proposing that the Town provide \$125,000 to fund a Master Plan for a West Lexington Greenway Corridor. This project is the necessary first step in developing a network of bicycle and walking trails that would connect all of Lexington's conservation lands on the west side of Route 128. The Master Plan would provide the Town with the resources to apply for additional State and Federal financial support to construct this trail system in future years. The centerpiece of this project would be the construction of an unpaved bicycle trail, similar in quality to the Minuteman National Park's Battle Road Trail, connecting the Minuteman Bikeway with the Battle Road Trail. The creation of such a trail network has broad support in the planning documents of various town boards and committees including the Town's Vision 2020 Plan, Comprehensive Plan, and Open Space Plan. This project is being co-sponsored by the Town's Recreation Committee, the Conservation Commission, the Lexington Conservation Stewards, and the Bicycle Advisory Committee.

Do you feel it is an appropriate use of a portion of Lexington's CPA money to provide seed money that might allow the Town to qualify for substantial future financial support in realizing some of its long range goals that would not otherwise qualify for inclusion in the annual operating budget? (The use of CPA money for this purpose has been approved by other communities across the Commonwealth.) If you feel that this is not a proper use of CPA funds, what alternative suggestions do you have for the Town to realize some of its long-range conservation and passive recreation goals, such as this project?

# CANDIDATES FOR TOWN-WIDE OFFICES

## Candidate for Moderator

The use of CPA money to provide seed money that might allow the Town to qualify for substantial financial support in realizing some of its long range goals that might not otherwise qualify for inclusion in the annual operating budget deserves careful consideration by Town Meeting.

As Moderator, however, I cannot give my opinion on this use of CPA funds. If the Moderator is to preside fairly and impartially over Town Meeting, her opinion on issues, persons or groups should not be known.

All questions facing Town Meeting deserve balanced, thoughtful consideration.

Therefore, the Moderator should make certain that the subject under debate is clear, town meeting practices and procedures are understood, and all points of view are fully explored. As Moderator I feel it is my role to protect and improve the process by which decisions are made which can affect the quality of life in Lexington. Last spring I held a meeting with town boards, committees and the TMMA to critique and refine the streamlined Town Meeting procedures that had been instituted to enable members to concentrate on the issues more quickly.

As Moderator I will continue to do everything possible to see that Town Meeting members receive the information needed to make informed choices and that citizen participants thoroughly understand Town Meeting procedures. Citizen article sponsors have been sent written instructions to aid them in preparing for Town Meeting. These citizens will be included in the Moderator's meeting with article sponsors during which we establish Town Meeting format, timing, chronology and note areas of potential disagreement. A workshop will again be held for new Town Meeting members to answer questions, explain legal issues, parliamentary procedures and land use as well as financial terms and concepts. I

will be readily available for consultation and explanation of meeting procedures to all citizens and officials wishing to be heard at Town Meeting. I will write a newspaper article to explain the protocol for citizen participation.

## Candidates for Selectman

In my opinion, the proposal to develop a Master Plan for a West Lexington Greenway Corridor is exactly the kind of project that the voters had in mind when they approved the Community Preservation Act. It not only meets the criteria, it combines conservation and recreation components, with the expectation of leveraging the project with State and Federal funding. Although there is much work needed to refine the concept into an operable plan, connecting the two bikeways utilizing existing conservation land in a way that preserves the environment while enhancing our enjoyment of it, happens to be right on target as a project for the Community Preservation Act.

I congratulate and thank those Lexington residents who have conceived of the idea of a West Lexington Greenway Corridor and have worked diligently to make it happen. The use of \$125,000 of CPA funds as seed money to secure long term funding for the bike and pedestrian trails connecting Lexington's conservation lands on the west side of Route 128 is eminently reasonable. It is my understanding that the Community Preservation Committee has already recommended the expenditure and I will certainly support its approval at Town Meeting.

This proposal for seed money uses CPA funds as they should be used, as a way to leverage taxpayers' dollars to gain even greater value for the community. An extended trail network will serve current and future generations not only by enhancing recreational opportunities, but also by linking two potential commuter routes, thus providing an incentive to minimize dependence on passenger cars, an important goal for a sustainable community.

The Minuteman Bikeway is one of the most successful projects in Lexington and has enhanced recreational opportunities, promoted use of non-polluting transportation modes, and contributed to an increase in the quality of life for people from many communities.

I am in favor of applying for CPA funds to develop a Master Plan for more bicycle and walking trails that would connect both within and outside of Lexington and will support that request if it comes to Town Meeting for a vote. ## CANDIDATES FOR TOWN MEETING

The CPC has recommended an appropriation for the West Lexington Greenway Master Plan Study of \$125,000 to Annual Town Meeting. As a

member and chair of the CPC, I feel this is an appropriate use of CPA funds. The current request, which was sponsored by the Conservation Commission, the Recreation Committee, the Bicycle Committee, and the Lexington Conservation Stewards, is to develop a Master Plan to connect Lexington's Minuteman Bikeway with the Battle Road Trail in Minuteman National Historical Park along with a network of passive recreation trails west of Rte.#128. The Master Plan is necessary to apply to federal and state funding sources for future construction of the trail.

This project promotes recreation and open space which are two goals of the Community Preservation Act as well as Lexington's Comprehensive Plan, Open Space Plan, and the Town's 20/20 Plan. This project would most likely not be funded by the Town due to the Town's fiscally tight budget so the recommended use of

CPA funds for this project is exactly why CPA was passed by the Massachusetts State Legislature and by Lexington last March. Lexington will receive matching funds from the state on October 15, 2007 of approximately \$2.3 million that will offset the cost of this study along with other CPA projects that Annual Town Meeting will vote on and have final approval.

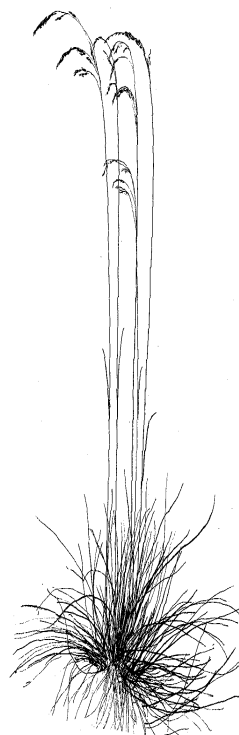

However, I do believe that CPA monies should be spent only on projects, such as this one, that Town Meeting would consider even in the absence of CPA funding. The rationale for the CPA itself, which I embraced on the Appropriation Committee when recommending adoption and as a Town Meeting Member when voting YES, is that it: (1) makes us eligible for state matching funds for a portion of our expenditures, and (2) compels the Town not to overlook taking at least a minimum degree of responsibility for conservation, recreation, housing, and historical preservation relative to other priorities. I do not view the CPA as a license to spend money on miscellaneous projects outside our regular budgeting process. Why, with a limited amount of money available from all sources, would we want to spend money on a project that we collectively feel is not as important as others we are opting not to do?

After reviewing the initial proposal at the Town Hall, the supplementary material provided to the CPC, and speaking with one of the sponsors and a member of the CPC, I believe that the Master Plan for the proposed Greenway is an appropriate use of CPA funds for recreation. The project clearly meets requirements of the CPA, is based on proposals made years ago which have gone unfunded, and is consistent with long term planning the town has gone undergone. Part of the purpose of the CPA is to ensure that at least some such projects see the light of day despite other fiscal pressures.

The project provides a good model of the kind of funding strategy we need in as many areas as possible – where money we do spend is leveraged to bring in other dollars. My opinion is also influenced by the high likelihood of federal funding for the construction of the Greenway itself - the Connector creates an alternative transportation route for those who would like to bicycle into towns further in toward Boston, and others have received even higher funds for projects with similar alternative transportation goals.

It does not seem to have closed out any other projects – there is still plenty of CPA funding left even after all the CPC-approved projects are forwarded to Town Meeting, and more money is due from the State in October.

I do hope that any reasonably anticipated continuing maintenance cost (such as some mowing of part of the Connector), and any potential revenue boost (perhaps from increased bike traffic through Lexington) will be mentioned in the presentation to Town Meeting. I do not demand that every governmental project be revenue neutral or positive - in fact, I think government should be, in part, about those very things which are needed but not profitable - so even if the potentially small operating charges outweigh any revenue which might to come to the Town, I still believe there are reasons enough to do the Study which would obtain the funds for construction. But I do think we should have reasonable estimates on those points when we ultimately vote on construction and hope the study will help provide such.

Lastly, I like that the Greenway project provides another chance to forge even more regional connections with our neighboring towns. Such partnership approaches to common issues often have served the Town well. They are particularly necessary when dealing with environmental issues.

I feel that it is appropriate to use CPA funds for the development of worthwhile conservation and recreation projects, and that it is to the Town's advantage to use CPA funds for a project that will later be funded by Federal or State grants. However, before I make a commitment to vote to approve the Western Greenway planning, two things must happen.

First, as a Town Meeting member I must consider the priority of each project that is recommended by the Community Preservation Committee (CPC) for CPA funding relative to other possible uses of CPA funds. This year, the Town is negotiating the purchase two parcels of open space though we won't know until later whether those negotiations are successfully concluded. The purchase of either parcel would be funded by the CPA. These negotiations are private; the public (myself included) has not been told the locations, sizes, possible costs, etc. of the parcels. Until the details of the proposed land purchases become public, it will not be entirely clear as to what the available CPA funds can cover. The CPC will also be recommending a number of other projects for CPA funding (these are unlikely to require the use of all of the CPA funds that will be available in FY 2008).

Second, before making a firm commitment in favor, I need to learn more about the proposed Western Greenway, e.g., the details of the route, whether there are serious problems in terms of wet areas, road crossings, ownership, etc., what the cost of construction might be, and what the prospects will be for funding via grants.

In summary, the proposed project has a lot of potential but needs to go through a reasonable approval process.
